**BOND ORDINANCE AMENDING AND SUPPLEMENTING
BOND ORDINANCE NUMBER 2015-15 (WHICH PROVIDES
FOR WATER TOWER IMPROVEMENTS) HERETOFORE
FINALLY ADOPTED BY THE BOROUGH COUNCIL OF
THE BOROUGH OF ELMER, IN THE COUNTY OF SALEM,
STATE OF NEW JERSEY, ON NOVEMBER 11, 2015, AS
AMENDED AND SUPPLEMENTED, TO AMEND THE
DESCRIPTION, TO INCREASE THE APPROPRIATION BY
\$255,000 AND TO INCREASE THE AUTHORIZATION OF
BONDS OR NOTES BY \$255,000**

**BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE
BOROUGH OF ELMER, IN THE COUNTY OF SALEM, STATE OF NEW JERSEY** (not
less than two-thirds of all members thereof affirmatively concurring), **AS FOLLOWS:**

SECTION 1. The bond ordinance of the Borough of Elmer, in the County of Salem, State of New Jersey (the "Borough"), heretofore finally adopted by the Borough Council thereof on November 11, 2015, numbered 2015-15 and entitled, "BOND ORDINANCE AUTHORIZING AND PROVIDING FOR WATER TOWER IMPROVEMENTS IN THE BOROUGH OF ELMER, COUNTY OF SALEM, NEW JERSEY; APPROPRIATING THE SUM OF \$500,000 THEREFOR; AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS OR BOND ANTICIPATION NOTES OF THE BOROUGH OF ELMER, COUNTY OF SALEM, NEW JERSEY, IN THE AGGREGATE PRINCIPAL AMOUNT OF UP TO \$325,000 MAKING CERTAIN DETERMINATIONS AND CONVENANTS; AND AUTHORIZING CERTAIN RELATED ACTIONS IN CONNECTION WITH THE FOREGOING", as amended and supplemented heretofore (the "Original Ordinance"), which Original Ordinance is hereby amended and supplemented, as follows:

SECTION 2. Section 7 of the Original Ordinance is hereby amended to read as follows,

“SECTION 7. (a) The improvements hereby authorized and the purposes for the financing of which the bonds are to be issued include various improvements to the Borough Water Storage Tower, which improvements shall include, but are not limited to, repainting and general capital repairs and improvements, the acquisition and installation of an emergency generator, and the replacement and installation of existing security systems including, but not limited to, fencing and gates, and all work, materials, equipment, labor and appurtenances necessary therefor and incidental thereto.

(b) The average period of usefulness of said improvements or purposes described in Section 7(a) within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the said bonds authorized by this bond ordinance, is 20 years.”

SECTION 3. For the improvement or purpose set forth in Section 7 of the Original Ordinance, as amended and supplemented hereby, there is hereby appropriated the additional sum of \$255,000, said sum being inclusive of \$175,000 as the amount of down payment required by the Local Bond Law, now available therefore by virtue of provisions in a previously adopted budget or budgets of the Borough for down payment or capital improvement purposes. The total appropriation of the Original Ordinance, as amended and supplemented hereby, is equal to \$755,000, including the sum of \$175,000 as the total down payment available therefor (the “Down Payment”).

SECTION 4. (a) In order to finance the cost of the improvement or purpose set forth in Section 7 of the Original Ordinance, as amended and supplemented hereby, not covered by the down payment, additional negotiable bonds or notes of the Borough in the amount of \$255,000 are hereby authorized to be issued by the Borough, such that the total authorization of negotiable bonds or notes to be issued by the Borough for the improvement or purpose set forth in Section 7 of the Original Ordinance, as amended and supplemented hereby, is equal to \$580,000.

(b) The estimated maximum amount of bonds or notes to be issued for the improvement or purpose set forth in Section 7 of the Original Ordinance, as amended and supplemented hereby, is equal to \$580,000.

(c) The estimated cost of the improvement or purpose set forth in Section 7 of the Original Ordinance, as amended and supplemented hereby, is equal to \$755,000, the

excess amount thereof over the said estimated maximum amount of bonds or notes to be issued therefor is the Down Payment available therefor.

SECTION 5. The Capital Budget of the Borough is hereby amended, as necessary, to conform with the provisions of this amendatory and supplemental bond ordinance and to the extent of any inconsistency herewith, a resolution in the form promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs (the “Director of the Division of Local Government Services”), will be on file in the office of the Clerk and will be available for public inspection.

SECTION 6. The Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the Office of the Clerk of the Borough and a complete executed duplicate thereof has been filed in the Office of the Director of the Division of Local Government Services, and such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided for in this amendatory and supplemental bond ordinance by \$255,000 and the said obligations authorized herein will be within all debt limitations prescribed by law.

SECTION 7. For the improvements or purposes set forth in the Original Ordinance, as amended and supplemented hereby, the additional sum of \$170,000 is hereby included for the items of expense listed in and permitted under N.J.S.A. 40A:2-20, making the total amount for such items of expense \$245,000, such total amount being included in the estimated cost indicated herein for the improvements or purposes set forth in the Original Ordinance, as amended and supplemented hereby.

SECTION 8. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by the Original Ordinance, as amended and supplemented hereby. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable property within the Borough for the payment of the obligations and the interest thereon without limitation as to rate or amount.

SECTION 9. The Borough hereby declares the intent of the Borough to issue the bonds or bond anticipation notes in the amount authorized in Section 4 of this bond ordinance and to use proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 2 of this bond ordinance and Section 7 of the Original Ordinance, as amended and supplemented hereby. This Section 9 is a declaration of intent within the meaning and for purposes of Treasury Regulations §1.150-2 or any successor provisions of federal income tax law.

SECTION 10. The Borough Chief Financial Officer is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The Borough Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

SECTION 11. The Borough covenants to maintain the exclusion from gross income under section 103(a) of the Code, of the interest on all bonds and notes issued under the Original Ordinance, as amended and supplemented hereby.

SECTION 12. Except as expressly amended and supplemented hereby, the Original Ordinance shall remain in full force and effect.

SECTION 13. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption and approval by the Mayor, as provided by the Local Bond Law.
