Borough of Elmer Minutes

December 12, 2018

CALL TO ORDER: A Regular Meeting of the Borough Council convened in the Borough Hall at 7:35 p.m. with Mayor Stemberger presiding.

FLAG SALUTE AND INVOCATION: Invocation was given by Mayor Stemberger, followed by the pledge of allegiance. Mayor Stemberger noted that adequate notice of the meeting was provided on January 8, 2018 pursuant to the Open Public Meetings Act.

ROLL CALL: Council President Lewis Schneider, Council Members Lynda Davis, Cynthia Nolan, Steven Schalick, James Zee, and Mayor Joseph Stemberger answered to the roll call. Absent was Council Member R. Matthew Richards. Also present were Solicitor Brian Duffield, Chief Financial Officer Cynthia Strang, and Clerk Sarah Walker.

APPROVAL OF MINUTES: Motion Davis second Zee to approve the minutes from the Regular Council Meeting held on November 14, 2018, and to dispense with the reading of the minutes.

Roll Call: Ayes: Schneider, Davis, Nolan, Schalick, Zee; Nays: None. Absent: Richards. Motion carried.

PUBLIC SESSION: Motion Davis second Zee to open the public portion of the meeting. All were in favor and the motion carried.

Robert Richards provided an update on the status of the Elmer Ambulance sale to the American Legion Ambulance and reported that the Water Tower one year inspection was completed.

Warren Collins, 105 Broad St., described problems with a recent Certificate of Occupancy (CO) inspection, particularly the costs of certifying the septic system. Realtors Gail & Tom Krwawecz, 689 Lower Mill Rd, also spoke about issues with the inspections and interpretation of the rules in the International Property Maintenance Code (IPMC) that could delay real estate transactions. Dave Newkirk, S. Main St., discussed costs of requirements as well. Solicitor Duffield noted that code officials are licensed by the state and there is a process for appealing a decision through the Salem County Construction Board of Appeals. Council members discussed the IPMC and the CO checklist and what other towns are requiring. The Solicitor noted that septic certifications are required in other towns he works with as part of determining that the property is safe for human occupancy. Mayor and Council suggested reviewing the current code; the Solicitor recommended contacting the inspector to discuss the concerns and remedies via a conditional CO until the concerns can be worked out.

Burroughs Timberman, 20 N. Main St., discussed issues regarding zoning on the property and concerns about cost and loss of business activities in town. Patrick Bryan, 209 Hitchner Ave, also spoke about a concern with the time it took Construction Code Officials to approve a permit for solar.

Motion Davis second Nolan to close the public portion of the meeting. All were in favor and motion carried.
